## Family-Agency Agreement

This Agreement is made this	day of	, 20,	between	A	Plus	Nannies	Inc
hereinafter called "A+ Nannies";	, and the Client.						

- 1. It is understood and agreed that A+ Nannies is not the Employee or the Employer in this agreement. Client realizes that if they pay more than \$1500.00 in any calendar year to one person, Client is liable for withholding and filing employment taxes for that person.
- 2. Client agrees to pay the temporary nanny/babysitter directly for services performed. (This will vary on their experience, job detail, and number of children)
- 3. Client recognizes that there will be a finder's fee charged to their credit card for every temporary nanny/babysitter visit. (This fee will range from \$25.00-\$35.00, depending on the notice given and job description, OR placement fee of \$350.00 for 30 days, or \$900.00 for 90 days. When booking for 3 months or longer, there will be a \$200.00 registration fee due at the beginning of search.
- 4. Client realizes there will be no refund in already scheduled and confirmed dates. If client cancels an already confirmed nanny with less than 48 hours notice, the Client will be charged the agency fee + the nanny's fee for the four hour minimum.
- 5. Client agrees that they will call A+ Nannies prior to the use of any temporary nanny/babysitter. Client also agrees that if they refer any of our candidates to a third party, without arranging the visit through the agency, this will result in a fine of \$1000.00 for liquidated damages, EVEN if the nanny declines the offer.
- 6. A+ Nannies cannot be a guarantor of the honesty or reliability of the nanny nor is A+ Nannies an agent of the nanny or vice versa. Accordingly, the Client hereby releases and agrees to hold A+ Nannies, its directors, officers, employees, successors, and assigns, harmless from any act of nonfeasance, misfeasance, or malfeasance by the nanny, nor will the Client hold A+ Nannies, its directors, officers, employees, successors, and assigns, liable for any other claim which she/he may have.
- 7. The Client agrees to fully indemnify and hold A+ Nannies, it directors, officers, employees, successors, and assigns, harmless from any and all claims, demands, losses, liabilities, damages or expenses for investigation or attorney's fees arising out of, or in any way related to, this agreement, including any personal injury or property damage.
- 8. This Agreement contains the entire agreement between A+ Nannies and the Client, and no statements, promises, or inducements made by either party or agent of either party that is not contained in this written Agreement shall be valid or binding; and this contract may not be enlarged, modified, or altered except in writing, signed by the parties herein.
